Terms and conditions of the Contractual Appointment

1. The contractual appointment will be made initially for one year and extendable till the completion of project based on performance.
2. The recruited project staff are eligible for leave as per project rules and **will have to give an undertaking at the time of joining.**
3. Mere fulfilling the essential qualification does not guarantee the selection. The applications received will be screened and the shortlisted candidates will be intimated through e-mail provided and the information regarding the interview will be shared with the shortlisted candidates on the e-mail id provided by the candidate. Candidate selected against the post will be intimated via email.
4. The conditions for employment will be same as that of the ICMR project staff on contract basis.
5. Age, qualification, experience etc. will be reckoned as on the last date of submission of application form. Age relaxation will be applicable as per GOI rules.
6. Hostel accommodation of any kind is not available with the Institute.
7. These positions are meant for temporary projects and co-terminus with the project.
8. Engagement of the above advertised Project Human Resource Positions will depend upon availability of funds, functional requirements, and approval of the Competent Authority.
9. Qualification & Experience should be in relevant discipline/ field and from an Institution of repute. Experience should have been gained after acquiring minimum essential qualification.
10. Persons already in regular time scale service under any Government Department/ Organizations are not eligible to apply.
